Daily Plan:
1. Hand out the requirements of office handouts.
2. Divide the class into 8 groups to research specific elected officials (Assign each group one.
President, House of Representatives, US Senate, US Supreme Court, Governor, House of
Delegates, State Senate, State Supreme Court)

- 3. The students will research their specific person/people and requirements to serve in this position.
- 4. The students will put their answers/pictures into a slide show program to show the other members in class.

Checking for Understanding: Class discussion-The teacher will ask each group to share their answers with the entire class.

Extended Questions:

1. Why are there requirements for holding political office?

2. Why do you think you must be older to run for President of the United States as opposed to running for West Virginia House of Delegates?
